## OFFICIAL RULES

**Last Updated: December 28, 2025**

**PLEASE READ CAREFULLY. BY REGISTERING FOR OR PARTICIPATING IN GOTGAME.AI, YOU AGREE TO BE LEGALLY BOUND BY THIS AGREEMENT.**

---

## 1. OVERVIEW & ACCEPTANCE

This Agreement governs your access to and use of **GotGame.ai** (the “**Platform**”), including participation in any GotGame.ai **skill-based contest** (the “**Contest**”).

By registering, accessing, or participating in the Platform, you acknowledge that you have read, understood, and agreed to this Agreement in its entirety.

If you do not agree, **do not participate**.

---

## 2. DEFINITIONS

- “**Sponsor**” means GotGame.ai.
  - “**Platform**” means the GotGame.ai website, applications, and services.
  - “**Contest**” means a GotGame.ai Skill-Based Contest session.
  - “**Participant**” means any registered user.
  - “**Content**” means images, videos, or audio presented during gameplay.
- 

## 3. ELIGIBILITY

You may participate only if you:

- Are **eighteen (18) years of age or older**
- Are a legal resident of the **United States**, except where prohibited
- Provide accurate and truthful registration information
- Are not an employee, contractor, officer, or immediate family member of Sponsor

Void where prohibited by law.

---

## 4. NO PURCHASE OR CONSIDERATION REQUIRED

- **No purchase, payment, or entry fee is required** to participate.
- Participation is free and voluntary.

- A purchase does **not** increase the chances of winning.
- 

## 5. CONTEST DESCRIPTION (SKILL-BASED)

GotGame.ai is a **skill-based contest** in which Participants analyze Content and determine whether it is:

- **AI-generated**, or
- **Human-created**

Winners are determined solely by **skill, knowledge, and judgment**, not chance.

---

## 6. CONTEST FORMAT, SEPARATE SESSIONS & AUTOMATED DETERMINATION

- Each Contest consists of **twelve (12) questions**.
- Each question presents Content.
- Participants must answer in real time.
- All answers are evaluated **objectively and automatically** by the Platform.

### Separate Contest Sessions

**Each Contest session constitutes a separate and independent skill-based contest with its own prize pool.**

Contest sessions are not cumulative, continuous, or aggregated across weeks or time periods.

### Automated Winner Determination

- **All eliminations, continuations, votes, and winner determinations are handled exclusively by automated systems.**
- **No human judgment, discretion, or subjective evaluation is involved in selecting winners.**
- Sponsor personnel do not influence, select, or alter outcomes except in cases of verified technical error or rule violation.

This is a **game of skill**, and skill predominates over any element of chance.

---

## 7. ELIMINATION, EXTRA LIVES & REFERRALS

Participants who answer a question incorrectly are eliminated unless an Extra Life is available.

### Extra Life Rules

- Each Participant may use **one (1) Extra Life per Contest session**.
- Extra Lives **cannot be purchased** and have **no cash value**.

- An Extra Life allows a Participant to remain eligible after **one (1) incorrect answer**.

### **How to Earn an Extra Life**

- A Participant must refer **three (3) unique individuals**.
- All three referrals must complete valid registration before the Extra Life is granted.
- Once verified, the Extra Life appears in the Participant's dashboard.

Extra Lives are non-transferable and limited to one per Contest.

---

## **8. PLAYER VOTING, EARLY CONCLUSION & ANTI-COLLUSION**

When **twenty (20) or fewer** eligible Participants remain, the Platform may initiate a vote allowing remaining Participants to decide whether to:

1. **Continue the Contest**, or
2. **End the Contest early and split the prize pool evenly**

### **Voting Rules**

- Each remaining Participant receives **one (1) vote**.
- Votes are recorded and resolved **automatically**.
- A **simple majority** determines the outcome.
- Voting results are **final and binding**.

### **Anti-Collusion & Coordinated Voting**

Participants may **not**:

- Coordinate votes outside the Platform
- Agree in advance on voting behavior
- Influence votes through off-platform communication
- Trade votes or enter quid-pro-quo arrangements

Sponsor reserves the right to invalidate votes, disqualify Participants, and withhold prizes if collusion or coordinated behavior is detected.

---

## **9. COMMUNITY CONDUCT & MODERATION**

Participants are expected to conduct themselves respectfully while using the Platform, including during live chat, comments, reactions, usernames, and any interactive features.

Sponsor reserves the right, **at its sole discretion**, to mute, remove, disqualify, suspend, or permanently ban any Participant whose conduct Sponsor determines to be:

- Abusive, harassing, threatening, or hateful
- Discriminatory, defamatory, or offensive
- Sexually explicit or obscene
- Disruptive, spammy, or intentionally annoying
- Intended to interfere with gameplay or other participants' experience
- In violation of these Terms or applicable law

### **Moderation Authority**

- Moderation actions may be taken **in real time**.
- Enforcement may occur **with or without warning**.
- Moderation decisions are **final and non-appealable**.

### **Effect of Removal**

- Removed Participants may be immediately disqualified from the Contest.
- Disqualified Participants forfeit eligibility to win prizes for that Contest session.
- Removal for conduct violations does not entitle a Participant to compensation or reinstatement.

---

## **10. TECHNICAL ERRORS & SYSTEM INTEGRITY**

The Platform relies on automated systems and third-party services that may experience interruptions or errors.

Sponsor is not responsible for issues caused by:

- Network outages or latency
- Device or browser incompatibility
- Platform interruptions
- Delayed or lost submissions
- User-side connectivity issues

### **Technical Error Resolution**

If a **verified technical error** materially affects the Contest, Sponsor may, in its discretion:

- Pause or restart gameplay
- Remove affected questions
- Adjust outcomes to preserve fairness
- Cancel the Contest

Sponsor's determination regarding technical errors and resolution is **final**.

---

## 11. WINNERS & PRIZES (UPDATED FOR EXTRA LIVES & VOTING)

Winners are Participants who, as determined by the Platform's **automated system**, meet one of the following conditions:

- **Remain eligible through completion of all Contest questions**, including through the valid use of an Extra Life, **or**
- **Remain eligible at the conclusion of a valid early-end vote** initiated under these Rules.

Eligibility is determined solely by whether a Participant remains active and eligible at the end of the Contest, as recorded by the Platform's automated systems.

A Participant is **not required to answer every question correctly** to be eligible to win, provided they remain eligible under these Rules.

Prizes:

- Are split evenly among all eligible winners
- Vary by Contest session
- Are subject to eligibility verification

Winners are responsible for all applicable taxes.

---

## 12. FINALITY OF RESULTS & NO APPEALS

- **All Contest results are final.**
- There is **no appeal process** for:
  - Automated scoring decisions
  - Eliminations
  - Voting outcomes
  - Winner determinations
  - Moderation or conduct decisions

By participating, you waive any right to dispute results except where prohibited by law.

---

## 13. FAIR PLAY & PROHIBITED CONDUCT

Participants agree not to:

- Use bots, scripts, or automation
- Create fake or duplicate accounts

- Manipulate referrals, votes, or outcomes
- Collude with other Participants
- Interfere with Platform integrity

Violations may result in immediate disqualification, prize forfeiture, and permanent suspension.

## 14. PLATFORM DISCLAIMERS

The Platform is provided “**as is**” with no guarantee of uninterrupted operation.

Participation is at your own risk.

---

## 15. PUBLICITY RELEASE

By participating, you grant Sponsor the right to use your name, likeness, voice, and participation details for promotional and broadcast purposes, where permitted by law, without additional compensation.

---

## 16. SMS & COMMUNICATIONS CONSENT

By registering, you consent to receive **Contest-related SMS messages**.

- Message and data rates may apply
  - Message frequency varies
  - Reply **STOP** to opt out
  - Reply **HELP** for assistance

## **Data Sharing**

- Personal data is **not sold**

## **18. LIMITATION OF LIABILITY**

To the maximum extent permitted by law, Sponsor is not liable for:

- Technical failures
  - Automated scoring outcomes
  - Platform interruptions
  - Participant disputes

## **19. BINDING ARBITRATION & CLASS ACTION WAIVER**

**PLEASE READ CAREFULLY — THIS AFFECTS YOUR LEGAL RIGHTS.**

Any dispute arising out of or relating to this Agreement, the Platform, or the Contest shall be resolved **exclusively by binding arbitration**, on an **individual basis only**.

Class actions and representative proceedings are waived.

The arbitrator's decision shall be final and binding.

## **20. FORCE MAJEURE**

Sponsor shall not be liable for failure or delay caused by events beyond its reasonable control, including natural disasters, power or internet outages, acts of war, government actions, labor disputes, or third-party service failures.

Sponsor may suspend, modify, or cancel the Contest without liability in such events.

## **21. GOVERNING LAW**

This Agreement is governed by applicable U.S. and state law, without regard to conflict-of-law principles.

## **22. CHANGES TO THIS AGREEMENT**

Sponsor may update this Agreement at any time. Continued participation constitutes acceptance of any changes.
