OFFICIAL RULES

PLEASE READ CAREFULLY. BY REGISTERING FOR OR PARTICIPATING IN GOTGAME.AI, YOU AGREE TO BE LEGALLY BOUND BY THIS AGREEMENT.

1. OVERVIEW & ACCEPTANCE

This Agreement governs your access to and use of GotGame.ai (the “Platform”), including participation in any GotGame.ai skill-based contest (the “Contest”).

By registering, accessing, or participating in the Platform, you acknowledge that you have read, understood, and agreed to this Agreement in its entirety.

If you do not agree, do not participate.

2. DEFINITIONS

- “**Sponsor**” means GotGame.ai.
 - “**Platform**” means the GotGame.ai website, applications, and services.
 - “**Contest**” means a GotGame.ai skill-based contest session.
 - “**Participant**” means any registered user.
 - “**Content**” means images, videos, audio, or other media presented during gameplay.

3. ELIGIBILITY

You may participate only if you:

- Are eighteen (18) years of age or older
- Are a legal resident of the United States, except where prohibited
- Provide accurate and truthful registration information
- Are not an employee, contractor, officer, or immediate family member of Sponsor

Void where prohibited by law.

4. NO PURCHASE OR CONSIDERATION REQUIRED

- No purchase, payment, or entry fee is required to participate.
 - Participation is free and voluntary.
 - A purchase does not increase the chances of winning.

5. CONTEST DESCRIPTION (SKILL-BASED)

GotGame.ai is a skill-based contest in which Participants analyze Content and respond to skill-based questions.

Question types may include, but are not limited to:

- Determining whether Content is AI-generated or human-created
- Counting or identifying objects within Content (e.g., “How many bananas are in this image?”)
- Identifying attributes, patterns, inconsistencies, or details within Content
- Making analytical judgments based on observation, reasoning, and attention to detail

The specific question types used in a Contest session may vary.

Winners are determined solely by skill, knowledge, perception, and judgment, not chance.

6. CONTEST FORMAT, STRUCTURE & AUTOMATED DETERMINATION

- Each Contest consists of a series of questions or rounds, the number and type of which may vary by Contest session.
- Each question presents Content for analysis.
- Participants must respond in real time or within the time parameters specified for that Contest session.
- All answers are evaluated objectively and automatically by the Platform based on predefined criteria.

Variable Contest Structure

- Contest sessions may include different question formats, difficulty levels, or analytical challenges.

- The number of questions, rounds, or stages may vary.
- Contest formats may include fixed-length sessions, shortened sessions, extended sessions, or other variations determined by Sponsor.
- The specific structure applicable to a Contest session will be determined by the Platform at the time the Contest begins.

Separate Contest Sessions

Each Contest session constitutes a separate and independent skill-based contest with its own prize pool.

Contest sessions are not cumulative, continuous, or aggregated across weeks or time periods.

Automated Winner Determination

- All eliminations, continuations, votes, scoring, and winner determinations are handled exclusively by automated systems.
- No human judgment, discretion, or subjective evaluation is involved in selecting winners.
- Sponsor personnel do not influence, select, or alter outcomes except in cases of verified technical error or rule violation.

This is a game of skill, and skill predominates over any element of chance.

6A. AI FILTERS, CONTENT TRANSFORMATION & DETECTION DISCLOSURE

Sponsor may apply proprietary AI-based filters, transformations, post-processing techniques, or metadata modifications (“AI Filters”) to Content, including Content originally created by humans.

AI Filters may be used to:

- Alter visual, audio, or metadata characteristics of Content
- Normalize, enhance, or standardize Content presentation
- Simulate, obscure, or challenge markers commonly relied upon by AI-detection tools

Participants acknowledge and agree that:

- Human-created Content may be modified using AI Filters
- AI-detection tools are imperfect and may produce false positives or false negatives
- Content may be intentionally designed or transformed to test a Participant’s analytical skill
- The use of AI Filters does not alter the skill-based nature of the Contest

Participants expressly waive any claim that the application of AI Filters:

- Misrepresents Content
- Creates unfair gameplay conditions
- Converts the Contest into a game of chance

All determinations remain based on Participant skill, judgment, and analysis, regardless of whether Content has been filtered, transformed, or modified by Sponsor.

7. ELIMINATION, EXTRA LIVES & REFERRALS

Participants who answer a question incorrectly are eliminated unless an Extra Life is available.

Extra Life Rules

- Each Participant may use one (1) Extra Life per Contest session.
- Extra Lives cannot be purchased and have no cash value.
- An Extra Life allows a Participant to remain eligible after one (1) incorrect answer.

How to Earn an Extra Life

- A Participant must refer three (3) unique individuals.
- All three referrals must complete valid registration before the Extra Life is granted.
- Once verified, the Extra Life appears in the Participant's dashboard.

Extra Lives are non-transferable and limited to one per Contest.

8. PLAYER VOTING, EARLY CONCLUSION & ANTI-COLLUSION

When a limited number of eligible Participants remain, as determined by the Platform, the Platform may initiate a vote allowing remaining Participants to decide whether to:

1. Continue the Contest, or
2. End the Contest early and split the prize pool evenly

Votes are recorded and resolved automatically. Results are final and binding.

Participants may not coordinate or influence votes outside the Platform.

9. COMMUNITY CONDUCT & MODERATION

Participants are expected to conduct themselves respectfully while using the Platform.

Sponsor reserves the right to mute, remove, disqualify, suspend, or permanently ban any Participant whose conduct violates these Rules or applicable law.

Moderation decisions are final and non-appealable.

10. TECHNICAL ERRORS & SYSTEM INTEGRITY

The Platform relies on automated systems and third-party services that may experience interruptions or errors.

If a verified technical error materially affects the Contest, Sponsor may pause, modify, restart, adjust, or cancel gameplay. Sponsor's determination is final.

11. WINNERS & PRIZES

Winners are Participants who remain eligible at the conclusion of the Contest, including through valid use of an Extra Life or early-end voting.

Prizes:

- Are split evenly among eligible winners
- Vary by Contest session
- Are subject to eligibility verification

Winners are responsible for all applicable taxes.

11A. PAYOUTS & PAYMENT RESPONSIBILITY

Payment Responsibility

Participants are responsible for providing accurate and complete payment information. Sponsor is not responsible for payments that fail, are delayed, returned, or sent to the wrong account due to incorrect or incomplete information.

PayPal Payouts

If a prize is paid via PayPal, the Participant must accept the payment within PayPal. If a PayPal payment is not accepted within PayPal's required time window and expires or is canceled, the payment will not be reissued.

Sponsor is not responsible for third-party payment platform actions, limitations, or policies.

12. FINALITY OF RESULTS & NO APPEALS

All Contest results are final.

No appeals are permitted for scoring, eliminations, voting, moderation, or winner determinations.

13. FAIR PLAY & PROHIBITED CONDUCT

Participants may not use bots, scripts, automation, fake accounts, manipulation, or collusion.

Violations may result in disqualification, forfeiture of prizes, and permanent suspension.

14. PLATFORM DISCLAIMERS

The Platform is provided "as is" with no guarantee of uninterrupted operation.

15. PUBLICITY RELEASE

By participating, you grant Sponsor the right to use your name, likeness, voice, and participation details for promotional purposes where permitted by law.

16. SMS & COMMUNICATIONS CONSENT

By registering, you consent to receive Contest-related SMS messages. Message and data rates may apply. Reply STOP to opt out.

17. PRIVACY POLICY

Personal data is collected solely for Contest operations and is not sold. Reasonable safeguards are used, but absolute security is not guaranteed.

18. LIMITATION OF LIABILITY

To the maximum extent permitted by law, Sponsor is not liable for technical failures, automated determinations, or participant disputes.

19. BINDING ARBITRATION & CLASS ACTION WAIVER

All disputes shall be resolved exclusively by binding arbitration on an individual basis.

20. FORCE MAJEURE

Sponsor is not liable for delays or failures caused by events beyond its reasonable control.

21. GOVERNING LAW

This Agreement is governed by applicable U.S. and state law.

22. CHANGES TO THIS AGREEMENT

Sponsor may update these Rules at any time. Continued participation constitutes acceptance.
